Goff's Clean Curtains are custom made to any dimensions and layout!

Curtains

- Curtains are constructed with a Heavy Duty 40 Mil double polished Clear USDA Grade PVC
- Material is non-porous and sheds water, solutions, and soils easily
- Rolled rimmed stainless steel grommets with spur washer on 12" centers
- Heat-sealed vertical seams prevent trapping of contaminants
- 6" overlap between curtain panels to prevent wash break through

Hardware

- Stainless Steel Track and Trolley Hardware System
- Open Trolley design to prevent bacteria from forming
- 2 Hardware Types available depending on usage (*see reverse side*)



Standard Stainless Hardware

- 304 Stainless Steel
- 1.25" Diameter Roller Tube
- 0.65 Wall Thickness
- Formed Stainless Steel with Delrin Ball Rollers and Integrated Hook

Goff's stainless hardware can be mounted 2 ways - Suspend or Angle Suspend. Please specify when ordering to receive proper brackets.

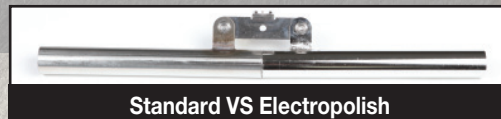


Suspend Mount

Heavy Duty Stainless Steel Hardware (Upgrade)

- 304 Stainless Steel
- 3.5" Tall Track Flange for ease of installation
- 1-5/8" Diameter Roller Tube
- Delrin Rollers with Stainless Steel Bushings and Stamped Stainless Roller Saddle and Swivel Hook. Heavy Duty Track comes standard polished.



Goff's also offers non-stainless (galvanized steel) style hardware.

A LIFETIME warranty on all stainless track & roller hardware. Goff's Enterprises may elect to repair or replace defective or damaged goods.

It may be safely used for contact with food; however, it may not be used as a food additive, which would be termed "direct". All components used in the manufacture of the material are sanctioned by the U.S. FDA for food applications under Title 21 part 174-182 of the Code of Federal Regulations.
